We had two guest speakers attend this meeting. (a) Bill Robins of Robins Insurance Agency came to speak to unit owners regarding HOA insurance policy/coverages particularly in regard to coverages regarding frozen/burst pipes. (b) Officer Jay Nicholson and Aimee Moffat from McKamey Animal Center came to talk unit owners regarding city laws regarding pets, leashing, licenses, permits, shots, etc.

- 7. Finance/Accounting Committee. JoAnne Harbort gave the Finance/Accounting Committee report.

 - We have 2 unit owners currently in collections (April Anderson 321) and (Andrew Kendle 454) and one ex unit owner Michael Andrews. Gayle Lattimore continues collection process for the Gardens.
